This section includes information on substances, mixtures, and all chemicals where a trade secret is claimed. The required information consists of: Substances. Chemical name. Common name and synonyms.

Information to include in safety data sheets. SDS must provide information on the: Hazards of the chemical and how to handle it safely, including storage and disposal. Physical and chemical properties of the chemical, as well as potential health and emergency response measures. Environmental effects of the chemical.

A Definition of Safety Data Sheet Safety data sheets (SDS) are a component of the Globally Harmonized System (GHS) of Classification and Labeling of Chemicals. The system standardizes hazard classification criteria and chemical hazard communication elements around the world.

Previously called MSDS (material safety data sheets) under the old OSHA HazCom Standard, safety Data Sheets are a critical part of GHS and are designed to communicate complete information about a chemical or mixture and how to mitigate any issues with handling or storage. Before GHS, the requirements for MSDSs were confusing and not very detailed.
